CANVASS OF PRESIDENTIAL PRIMARY ELECTION

FEBRUARY 22, 2000

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, FEBRUARY 23, 2000, IN THE FOURTH FLOOR COMMISSION CHAMBERS OF THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE 2000 PRESIDENTIAL PRIMARY ELECTION HELD ON TUESDAY, FEBRUARY 22, 2000. THE FOLLOWING OBSERVATIONS WERE MADE BY THE BOARD MEMBERS DURING THE CANVASS OF VOTES. THE MEMBERS PRESENT WERE:

CHAIRMAN WOZNIAK CALLED THE BOARD OF CANVASSERS TO ORDER AT 9:00 A.M.

AN ORGANIZATIONAL MEETING WAS PROPOSED TO ELECT OFFICERS FOR 2000 AND 2001. THE CHAIRMAN CONDUCTED THE ELECTION AND OPENED NOMINATIONS FOR THE OFFICE OF CHAIRMAN.

MR. CHEVALIER MOVED TO NOMINATE ALVIN APPOLD FOR CHAIRMAN. MOTION WAS SECONDED BY DOLORES NIEDZINSKI. THERE WERE NO FURTHER NOMINATIONS. MR. APPOLD WAS ELECTED BY A VOTE OF 4 YEAS, 0 NAYS.

NOMINATIONS WERE OPENED FOR THE OFFICE OF VICE CHAIRMAN.

MR. CHEVALIER MOVED TO NOMINATE DOLORES NIEDZINSKI FOR VICE CHAIRMAN. MOTION WAS SECONDED BY MR. APPOLD. THERE WERE NO FURTHER NOMINATIONS. MS. NIEDZINSKI WAS ELECTED BY A VOTE OF 4 YEAS, 0 NAYS.

THERE WERE NO OTHER OFFICERS TO BE ELECTED.
