JANUARY 12, 1993

THE BAY COUNTY BOARD OF CANVASSERS MET ON JANUARY 12, 1993 IN THE OFFICE OF THE BAY COUNTY CLERK TO CONDUCT A 1993 ORGANIZATIONAL SESSION PRIOR TO THE CANVASS OF THE VOTES CASE IN A FRANKENLUST TOWNSHIP SPECIAL ELECTION REGARDING REZONING FOR PROPOSED TRAILER PARK AREA. THE MEETING WAS CALLED TO ORDER BY CLERK BARB ALBERTSON AT 2:00 P.M. THE FOLLOWING MEMBERS WERE PRESENT.

THE FIRST ORDER OF BUSINESS WAS THE ELECTION OF A CHAIRMAN OF THE BOARD OF CANVASSERS FOR 1993. IT WAS MOVED BY RICHARD BRZEZINSKI AND SUPPORTED BY DONALD CHEVALIER THAT WALT WOZNIAK SERVE AS CHAIRMAN OF THE BOARD OF CANVASSERS FOR 1993. THE MOTION CARRIED BY A VOICE VOTE OF 3 YEAS, 0 NAYS.

NEXT ORDER OF BUSINESS WAS THE ELECTION OF A VICE-CHAIRMAN OF THE BOARD FOR 1993. IT WAS MOVED BY DON CHEVALIER AND SUPPORTED BY WALT WOZNIAK THAT WALLACE NIELSEN SERVE AS VICE CHAIRMAN OF THE BOARD FOR 1993. MOTION WAS PASSED BY VOICE VOTE OF 3 YEAS, 0 NAYS.

THE BOARD PROCEEDED TO CANVASS THE VOTES CAST AT THE SPECIAL ELECTION HELD IN FRANKENLUST TOWNSHIP ON THE DATE OF JANUARY 11, 1993. AFTER CONCLUSION OF A CANVASS, THE BOARD CERTIFIED THAT THE SPECIAL ELECTION WAS DEFEATED BY A VOTE OF 153 YEAS, 725 NAYS AND EIGHT (8) SPOILED BALLOTS.

WITH NO FURTHER BUSINESS TO CONDUCT, THE BOARD ADJOURNED THE ORGANIZATIONAL SESSION/SPECIAL ELECTION CANVASS AT 3:00 P.M.
