ITEM #1 ON STATEMENT OF VOTES WAS LEFT BLANK. (NO WRITE IN DECLARED)

PATTI BROUGHT IN THE AV LIST THAT WAS PUT IN THE WRONG ENVELOPE WHEN ALVIN BROUGHT IT IN ON ELECTION NIGHT.

KAWKAWLIN PRECINCT 2

NO CHECK MARKS ON ELECTION INSPECTORS PREPARATION CERTIFICATE IN POLL BOOK. CANVAS BOARD AGREES WITH RECOMMENDATION OF TOWNSHIP CLERK NOT TO COUNT THE PROVISIONAL BALLOT OF THE VOTER WHO HAD RECENTLY MOVED TO THE TOWNSHIP AND WHO HAD REGISTERED ON OCTOBER 12, 2007, AFTER THE REGISTRATION DEADLINE OF OCTOBER 9, 2007. HE WAS A PROVISIONAL VOTER AND WAS DIRECTED TO VOTE AT THE CORRECT PRECINCT WHICH THE CANVASS BOARD CONFIRMED HE DID.
