CANVASS OF THE NOVEMBER 6, 1990 GENERAL ELECTION
NOV. 8, 1999, ORGANIZATIONAL SESSION

THE BAY COUNTY BOARD OF CANVASSERS MET FOR AN ORGANIZATIONAL SESSION ON WEDNESDAY, NOVEMBER 7, 1990 PURSUANT TO STATUTE MCLA 168.821. ALL MEMBERS WERE PRESENT:

CHAIRMAN BRZEZINSKI CALLED THE MEETING TO ORDER AT 1:00 P.M. FOR THE PURPOSE OF ORGANIZING AND MAKING PLANS AND ARRANGEMENTS FOR THE 1990 GENERAL ELECTION CANVASS.

CHAIRMAN BRZEZINSKI STATED THAT THE BOARD WOULD STAY IN SESSION UNTIL THE TALLY CLERKS COMPLETED ALL TALLIES AS IN THE PAST THEY HAD NOT BEEN PRESENT AT THE TIME THE CLERKS COMPLETED THE TALLY AND WERE NOT AVAILABLE FOR QUESTIONING AND REVIEWING OF THE TOTALS AT THE TIME THE TALLY CLERKS WERE AVAILABLE.

CHAIRMAN BRZEZINSKI ALSO STATED THAT THE CLERK WAS TO MAKE AVAILABLE A BALLOT CAN AND SEALS SO THAT AT ALL TIMES WHEN THE BOARD NEEDED TO VACATE THE ROOM WHERE THE CANVASS WAS BEING DONE, ALL MATERIALS WOULD BE PLACED IN THE BALLOT CAN AND SEALED.

THE CLERK STATED THAT ON WEDNESDAY, NOVEMBER 14, 1990, IF THE BOARD NEEDED TO MEET, THEY WOULD HAVE TO MEET IN ANOTHER CONFERENCE ROOM- THAT BEING THE EXECUTIVE'S CONFERENCE ROOM ON THE AFTERNOON OF THE 14TH.

CHAIRMAN BRZEZINSKI STATED THAT THE BOARD WOULD MEET ON THURSDAY, NOV. 8, 1990 AT 9:00 A.M. AND PROCEED WITH THE CANVASS. THE TALLY CLERKS HAD BEEN NOTIFIED TO COME AT THAT TIME AND WORK UNTIL FRIDAY, NOVEMBER 9, 1990. THE CANVASS WOULD THEN BE RECESSED UNTIL TUESDAY, NOVEMBER 13, 1990 AT 9:00. (COUNTY BUILDING CLOSED MONDAY, NOVEMBER 12, 1990 IN OBSERVANCE OF VETERANS DAY).

THE BOARD WOULD ATTEMPT TO COMPLETE THE CANVASS BY THAT TIME, IF POSSIBLE.

BEING NO FURTHER BUSINESS WAS TO COME BEFORE THE BOARD, WALTER WOZNIAK MOVED TO ADJOURN THE ORGANIZATIONAL SESSION AND DONALD CHEVALIER SUPPORTED THE MOTION. THE MEETING ADJOURNED AT 1:30 P.M. BY A VOTE OF 4 YEAS, 0 NAYS.
