

**BAY COUNTY BOARD OF CANVASSERS**  
**CANVASS OF 11/8/94 GENERAL ELECTION**

THE BAY COUNTY BOARD OF CANVASSERS CONVENED ON WEDNESDAY, NOVEMBER 9, 1994 FOR THE PURPOSE OF CANVASSING THE RESULTS OF THE NOVEMBER GENERAL ELECTION. THE FOLLOWING MEMBERS WERE PRESENT:

WHILE REVIEWING THE ELECTION RESULTS, THE CANVASSERS RECORDED THE FOLLOWING OBSERVATIONS WITHIN THE VARIOUS CITIES AND TOWNSHIPS.

**BAY CITY, WARD 1, PRECINCT 1**  
THE CLOSING FIGURES WERE NOT ENTERED INTO THE RECORD TO DETERMINE THE NUMBER OF VOTERS. IN COLUMN #23, THE TOTAL NUMBER OF VOTES CAST FOR PETER O'CONNELL READ 59 VOTES AND SHOULD HAVE READ 53 VOTES CAST.

**BAY CITY, WARD 3, PRECINCT 1**  
IN COLUMN #21A, THE TOTAL WAS INCORRECTLY RECORDED. THE TOTAL SHOULD BE 96 WHILE THE RETURN SHEET READ 109 VOTES. THE TOTALS WERE NOT LEGIBLE IN COLUMNS 11A, 12A AND PROPOSAL B.

**BAY CITY, WARD 3, PRECINCT 2**  
IN COLUMN 24A, THE TOTAL SHOULD READ 145 WHILE THE RETURN SHEET REFLECTED 149 VOTES.

**BAY CITY, WARD 4, PRECINCT 1**  
THE OPENING NUMBERS ON THE PROTECTIVE COUNTER WERE NOT LISTED. BOARD MEMBERS REFERRED TO THE COUNTY CLERK'S COPY FOR THE FIGURES.

**BAY CITY, WARD 4, PRECINCT 2**  
THE TOTALS WERE OMITTED FROM THE BOARD OF CANVASSERS RETURN SHEET. NOTES WERE ADDED ONCE COMPARED WITH THE COUNTY CLERK'S COPY OF THE RETURN SHEET.

PROPOSAL B-THE "YES" FIGURES DID NOT AGREE WITH THE CLERK'S COPY. CLERK'S COPY READ 131 YES AND THE BOARD OF CANVASSERS COPY READ 181 YES VOTES.

COLUMN 1A FIGURES DID NOT AGREE, CLERK'S COPY READ 120 VOTES AND THE CANVASSERS READ 170 VOTES.

**BAY CITY, WARD 5, PRECINCT 2**

THE OPENING PROTECTIVE COUNTER NUMBER ON MACHINE NUMBER 111502 WAS INCORRECT. IT WAS LISTED AS 02872 AND SHOULD HAVE BEEN 20872. THE TOTAL FIGURE IN COLUMN 25A WAS INCORRECT, WAS LISTED AS 115 AND SHOULD BE 215.

THE BALLOT CAN WAS CLOSED WITH SEAL NO. 86253 AT 4:30 P.M. AS THE BOARD RECESSED FOR THE DAY. THE BOARD RECONVENED ON NOVEMBER 10, 1994 AT 8:30 A.M. SEAL NUMBER 86253 WAS REMOVED FROM THE BALLOT CAN.

**BAY CITY, WARD 6, PRECINCT 3**

COLUMN 28B LISTED THE TOTAL AS 84 VOTES AND SHOULD HAVE BEEN 82. THE CLERK'S COPY WAS ALSO RECORDED AS 84 VOTES.

**BAY CITY, WARD 7, PRECINCT 3**

THE CITY CHARTER QUESTION "NO" VOTES TOTAL READ 175 AND SHOULD HAVE BEEN 165 TOTAL. (CLERK'S COPY READ A TOTAL OF 175).

**BAY CITY, WARD 9, PRECINCT 1**

JUVENILE HOME MACHINE NO. 73270, "YES" VOTES READ 71 WHILE THE CLERK'S COPY READ 77 VOTES. THE TOTAL ON THE CANVASS BOARD'S RETURN SHEET WAS CHANGED FROM 148 TO 142.

**BAY CITY A.V #1, A & B**

THE NUMBER OF BALLOTS RETURNED 934. ONE (1) SPOILED BALLOT. THREE UNVOTED BALLOTS, BALANCE 930. TAPE INDICATED THE TOTAL BALLOTS CAST WAS 929 THEREFORE A DIFFERENCE IN ONE (1) BALLOT.

THE CANVASSERS CONCLUDED THIS MORNING WITH THE CLOSURE OF THE BALLOT CAN WITH SEAL NO. 86213. BOARD MEMBERS RECESSED FOR LUNCH AT 11:45 A.M. THE MEETING RECONVENED AT 12:45 P.M. WITH THE REMOVAL OF SEAL NO. 86213 FROM THE BALLOT CAN.

**AUBURN A.V.**

ONLY ONE PERSON SIGNED CERTIFICATE AT THE CLOSE OF BUSINESS.

**BANGOR TWP., PRECINCT 2**

COLUMN 3B, MACHINE NO. 73300, RECORDED AS 194. THE NUMBER OF VOTES SHOULD BE 94. THE TOTAL VOTES FOR COLUMN 3B IS CORRECT.

**BANGOR TWP., PRECINCT 3**

THE OPENING AND CLOSING NUMBERS ON MACHINE NUMBER 75552, PROTECTIVE COUNTER WERE NOT RECORDED.

THE POLL BOOK INDICATED 704 VOTERS IN THE PRECINCT BUT THE TOTAL NUMBER OF VOTERS ON THE RETURN SHEET WAS 696. THE DIFFERENCE WAS 8 VOTERS.

**BANGOR TWP., PRECINCT 7**

COLUMN 17A-NO VOTES ENTERED FOR COMM. BRISSETTE. THE BOARD OF CANVASSERS HAD TO RELY ON THE INFORMATION CONTAINED WITHIN THE CLERK'S ENVELOPE.

**BANGOR TWP., PRECINCT 8**

COLUMN 17A-THE TOTAL VOTES SHOULD BE 321 INSTEAD OF 221 AS SUBMITTED.

**BANGOR TWP. A.V.'S**

THE ELECTION INSPECTORS DID NOT SIGN THE INSPECTOR CERTIFICATE IN THE BACK OF THE POLL BOOK.

**FRANKENLUST A.V.'S**

THE CLOSING NUMBER ON THE PROTECTIVE COUNTER WAS NOT LISTED.

THE BOARD CLOSED THE BALLOT CAN WITH SEAL NUMBER 86294 AND RECESSED THIS DATE AT 4:45 P.M. BOARD MEMBERS RECONVENED AT 9:00 A.M. ON DAY 3 OF THE CANVASSING. THEY REMOVED THE SEAL FROM BALLOT CAN NUMBER 86294.

**HAMPTON NO. 2**

NO INFORMATION FURNISHED ON CERTIFICATE NO. 1. THE BOARD USED THE FIGURES PROVIDED IN THE COUNTY CLERK COPY OF THE RETURN SHEET.

**HAMPTON NO. 3 -A.V.**

ON MACHINE NO. 95212, THEY RECORDED THE SEAL NUMBER INSTEAD OF THE PROTECTIVE COUNTER NUMBER.

ON NOVEMBER 17, 1994 THE BOARD OF CANVASSERS RECESSED AT 11:55 A.M. FOR A LUNCH BREAK. THE BALLOT CAN WAS SEALED WITH STATE OF MICHIGAN SEAL 86252. AFTER LUNCH THE BOARD WAS SCHEDULED TO CANVASS THE MATERIALS FOR KAWKAWLIN TOWNSHIP. THE BOARD RECONVENED AT 12:50 PM AND REMOVED SEAL NUMBER 86252 FROM THE ELECTION CAN.

**KAWKAWLIN TWP., PRECINCT 2**

THE CLOSING NUMBER FOR MACHINE NUMBER 94742 WAS NOT LISTED. THE OPENING NUMBER FOR THE PROTECTIVE COUNTER WAS ALSO USED ON CERTIFICATE NUMBER 2.

**KAWKAWLIN A.V.'S**

THE DISTRICT NUMBER AND CANDIDATE NAMES DO NOT COINCIDE.

**MERRITT TWP. A.V.'S**

THE NUMBER OF VOTERS LISTED IN THE POLL BOOK WAS 93 WHILE THE NUMBER OF VOTERS SHOWN ON THE PROTECTIVE COUNTER NUMBER WAS 92.

**MONITOR TWP., PRECINCT 2**

THE CLOSING PROTECTIVE COUNTER NUMBER ON MACHINE NUMBER 86129 SHOULD BE 22895.

**MONITOR TWP., PRECINCT 3**

THE OPENING PROTECTIVE COUNTER NUMBER ON MACHINE NUMBER 114512 SHOULD BE 16689.

**PINCONNING TWP.**

PROPOSAL B- YES 411 VOTES, NO 343 VOTES WHICH TOTALS 754. THE NUMBER OF VOTERS WAS 7.

**PORTSMOUTH TWP. A.V.'S**

ALL PRECINCT WORKERS DID NOT SIGN THE CLOSING CERTIFICATE IN THE POLL BOOK.

THE BOARD CLOSED THE BALLOT CAN WITH SEAL NUMBER 86270 AND MOVED FOR AN ADJOURNMENT AT 4:15 P.M. ON 11/17/94.

THE BOARD CONVENED AT 8:50 A.M. ON NOVEMBER 18, 1994 AND REMOVED SEAL NUMBER 86270 FROM THE BALLOT CAN.

FOLLOWING REVIEW OF THE REMAINING MATERIALS, THE BOARD ADJOURNED AT 2:00 P.M. ON NOVEMBER 18, 1994.
