CANVASS OF MAY 6, 2008 ELECTION**

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, MAY 7, 2008, AT THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, MAY 6, 2008. THE MEMBERS PRESENT WERE:

BANGOR AV TOTALS WERE ADDED INTO THE PRECINCTS DUE TO THE DIFFERENCE IN PROGRAMMING FROM BAY COUNTY TO VENDOR. NO PROPOSALS WERE PRESENTED TO VOTERS FOR CONSIDERATION.

**BANGOR TOWNSHIP, PRECINCT 7 & 8**




**BANGOR TOWNSHIP, AVCB**
