THE BAY COUNTY BOARD OF CANVASSERS MET ON FRIDAY,
JULY 19, 1991 IN ORDER TO PRODUCE A COPY OF A BALLOT
CAST AT THE PINCONNING ANNUAL SCHOOL ELECTION WHICH
HAD BEEN HELD JUNE 10, 1991. THE MEETING WAS CALLED
TO ORDER BY THE CHAIRMAN OF THE BOARD, DON CHEVALIER
AT 10:10 A.M. WITH THE FOLLOWING MEMBERS PRESENT.

CHAIRMAN CHEVALIER REQUESTED CLERK ALBERTSON READ
THE CORRESPONDENCE RECEIVED FROM MR. KEN SEYUIN FOR
A PHOTOCOPY OF A BALLOT ORIGINALLY CHALLENGED THE DAY
OF THE CANVASSER'S RECOUNT HELD JUNE 27, 1991.

A LETTER FROM CANDIDATE MAIDA WAS ALSO READ. THIS
COMMUNICATION REQUESTED COPIES OF ANY AND ALL DOCU-
MENTS WHICH MR. SEYUIN MIGHT HAVE RECEIVED.

MOTION #1: IT WAS MOVED BY RICHARD BRZEZINSKI THAT
THE BALLOT CAN BE OPENED AND THE BOARD
PROCEED WITH LOCATING THE BALLOT MADE
REFERENCE TO. WALT WOZNIAK SUPPORTED
THE MOTION AND IT WAS CARRIED BY ROLL
CALL OF 3 YEAS, 0 NAYS.

BEFORE ACTUALLY OPENING THE BALLOT CAN NUMBERED TWO,
CHAIRMAN CHEVALIER VERIFIED THE SEAL NUMBER SOAS TO
CORRESPOND WITH THE POLL BOOK RECORD. THE CLERK RE-
CORDED SEAL NO. 438508 ON THE CAN AND THE SAME WAS
AFFIXED TO THE BALLOT CAN. BALLOT BAG SEALS HAD
CORRESPONDED WITH SEAL NO. 438501.

THE BOARD LOCATED AND MADE COPIES OF THE BALLOT
ORIGINALLY CHALLENGED BY MR. SEYUIN. AFTER MAKING
PHOTOSTATIC COPIES OF THE BALLOT AND EXHIBIT SHEET,
THE CLERK HIGHLIGHTED THE WORDS "COPY OF THE ORIGINAL"
AND THE BOARD MEMBERS INITIALED THE COPIES & RETURNED
THE ORIGINAL TO THE BALLOT BAG. THE CANVASSERS RE-
SEALED THE BALLOT BAG WITH SEAL #438600 AND SEALED

THE BALLOT CAN WITH SEAL NUMBER 438596.

A COPY OF THE BALLOT WAS GIVEN TO MR. SEYUIN AT THAT TIME. COPIES WERE TO ALSO BE SENT TO MR. MAIDA TO COMPLY WITH HIS REQUEST.

MOTION #2: RICHARD BRZEZINSKI MOVED TO ADJOURN THIS SESSION OF THE BOARD AND THE MOTION WAS SUPPORTED BY WALT WOZNIAK. THE MEETING WAS ADJOURNED AT 10:25 A.M. BY ROLL CALL VOTE OF 3 YEAS, 0 NAYS.
