BAY COUNTY BOARD OF CANVASSERS

DUE TO THE RESULTS OF A RECOUNT, A TIE VOTE WAS DECLARED BY THE BAY COUNTY BOARD OF CANVASSERS, AND THE FOLLOWING PROCEDURE WAS FOLLOWED.

A DRAW BY LOT FOR 9TH DISTRICT COUNTY COMMISSIONER SEAT WAS HELD ON FRIDAY, SEPTEMBER 5, 1986, AT 12:00 NOON IN THE CITY COMMISSIONERS CHAMBERS, CITY HALL, BAY CITY, MICHIGAN.

THE CANDIDATES MET WITH COUNTY CLERK BARBARA ALBERTSON AT WHICH TIME TWO SLIPS OF PAPER WERE PUT IN A JURY BOX IN UNIDENTIFIABLE SEALED CAPSULES. ONE STATED "NOMINATED TO BE ELECTED" AND THE OTHER ONE STATED "NOMINATED NOT TO BE ELECTED."

A COIN WAS FLIPPED TO DECIDE WHICH CANDIDATE WOULD DRAW FROM THE LOT FIRST. IT WAS DECIDED BY FLIP OF THE COIN THAT MR. RICHARD J. HART WOULD BE THE FIRST TO DRAW.

UPON MR. EUGENE TACEY DRAWING, THE TWO SIMULTANEOUSLY OPENED THE CAPSULES. THE RESULTS READ: MR. RICHARD HART, NOMINATED TO BE ELECTED, AND MR. EUGENE TACEY NOMINATED NOT TO BE ELECTED.
