**STATEWIDE BALLOT PROPOSALS:**

**PROPOSAL 14-1**

The purpose of the referendum is to approve or disapprove Public Act 408 of 2012, which allocates use tax revenue for various local purposes.

**LOCAL BALLOT PROPOSALS:**

**Garfield Township Fire Protection Millage Renewal Proposal**

This proposal is for renewal of 1 mill (\$1.00 per \$1,000.00 of taxable value) for a period of 3 years for the purpose of operating the Township Fire Dept. and maintaining the Fire Hall.

**Garfield Township Renewal of Extra Voted Millage for the Purchase of Fire Fighting Equipment**

This proposal is for renewal of ½ mill (\$.50 per \$1,000.00 of taxable value) for a period of 3 years for the purpose of purchasing fire fighting equipment for the Garfield Township Fire Department.

**Kawkawlin Township Road Millage Increase Proposal**

This proposal is for an increase of 1 mill for four years for the purpose of construction, maintenance and improvement of local public roads in Kawkawlin Township.

**Charter Township of Monitor Road Millage Proposal**

This millage proposal is for an increase of 1.95 mills (\$1.95 per \$1,000.00 of taxable value) for a period of 10 years for the purpose of construction, maintenance and improvement of the local public roads in Charter Township of Monitor.

**Portsmouth Township Road Millage Proposal**

This millage proposal is for an increase up to 1.5 mills (\$1.50 per \$1,000.00 of taxable value) for a period of 5 years for the purpose of raising revenues for the maintenance and improvement of public roads in Portsmouth Township.

**SCHOOL DISTRICT BALLOT PROPOSALS:**

**Essexville/Hampton School District Bond Proposal**

The millage proposal is for 7 mills over 30 years that will generate \$41 million dollars to modernize four school buildings and athletic facilities; upgrade technology and security.

**Pinconning Area Schools Operating Millage Renewal Proposal**

This millage proposal is a renewal of 18 mill non-homestead operating millage for a period of 10 years (\$18.00 on each \$1,000 of taxable valuation) to provide funds for operating purposes.

**Reese Public Schools Millage Renewal Proposal**

This millage proposal is a renewal of 1.5 mills (\$1.50 on each \$1,000 of taxable valuation) for a period of 5 years to continue to provide for a sinking fund to be used for the construction or repair of school buildings and all other purposes authorized by law.
