

**NOTICE LAST DAY TO REGISTER  
REGISTRATION OF THE ELECTORS  
OF BAY COUNTY, MICHIGAN  
NOVEMBER 3, 2015 ELECTION**

All electors are hereby given notice that an Election will be held in Bay County, Michigan on Tuesday, November 3, 2015 at which time the following offices and ballot proposals are to be voted for:

**Offices:**

Bay City Mayor  
Bay City Commissioners Wards 2, 4, 6 and 8  
City of Essexville Council Members

**Proposals:** The following is a summary of the 2 proposals which shall be considered on the November 3, 2015 ballot.

**CITY OF ESSEXVILLE BOND PROPOSITION**

Shall the City of Essexville borrow an amount not to exceed \$6,950,000 and issue general obligation unlimited tax bonds for the purpose of paying the cost of making water supply system improvements consisting of a water transmission line that will connect the City system to the Bay County Regional Water Treatment Facility. The max number of years outstanding is 40 years with the estimated levy in the first year is 2,6931 and estimated simple average annual millage to retire the bonds.

**FREELAND SCHOOL DISTRICT BOND QUESTION**

Shall the Freeland Community School District borrow the sum of not to exceed \$22,395,000 and issue general obligation unlimited tax bonds for the purpose of erecting, furnishing and equipping additions and to remodel, furnish and equip school buildings, technology, bus garage, purchase school buses, athletic fields, playgrounds and sites.

(In 2016 is 3.29 mills to the max of 4.0 mills on \$1,000.00 of taxable value)

Electors who wish to vote in the November Election must be registered to vote no later than **5:00 p.m. on Monday, October 5, 2015** in accordance with Michigan Compiled Law 168.498.

At the specified agency for clients receiving services through the Michigan Office of Human Services, the Department of Community Health, Michigan Jobs Commissioner and some offices of the Commission for the Blind. Also, at the Military Recruitment offices for persons enlisting in the Armed Forces.
