

REPORT TO THE COUNTY EXECUTIVE **SECOND QUARTER, 2018**

The following reports for the 2nd quarter of 2018 are presented to the County Executive:

ADMINISTRATIVE SERVICES

- Attended various events with Veterans Affairs including one in Pinconning, and one at the Riverside facility here in Bay City.
- Worked with MMRMA and various departments regarding automobile damage claims.
- Finalized new flooring and building damage plans at the Bay County Animal Control building. Work will be completed in July.
- Worked with various County offices in processing Freedom of Information Act (FOIA) responses for the Second Quarter. Many responses were took coordination between several departments including the Sheriff Department, 911 Dispatch, Animal Control, and the Health Department.
- Attending a Bay City meeting regarding the bridges in Bay City.
- Helped coordinate with the Bay County Humane Society an event at the Bay County Central Bark Park.
- Attended various wage study meetings held at the Bay County Civic Arena.
- Arranged for the Veterans Service Officer and Soldiers & Sailors Relief Coordinator to attend accreditation training in Lansing.
- Met and discussed various Soldiers & Sailors topics with staff.
- Assisted the Veterans Offices in coordinating financial processing expenditures through & Sailors Relief and Veteran Transportation Services.
- Helped the Soldiers & Sailors Relief Commission with the donation of a Chrysler Town & Country minivan donation to the Veterans Transportation Program.
- Resolved a number of constituent inquiries and communications made to the Administrative Services office.
- Prepared and finalized the various 2019 departmental budgets.
- Reviewed various RAP Grant Categories with MMRMA.
- Researched and discussed various training opportunities for Bay County that would be provided through MMRMA on an annual basis.
- Attended an annual MIPRIMA event that took place in Bloomfield Hills, MI.
- Toured the Riverside and Community Center sites with staff.
- Attended the Safety & Security Meeting.

Animal Control

- The Shelter took in 218 cats and 215 dogs and 6 other animals for a total of 439 animals.
 - Owners claimed 8 cats and 58 dogs.
 - o We adopted out 63 cats, 44 dogs, and 4 others were adopted.
 - o 30 cats and 38 dogs were euthanized per owner's request.
 - o 28 cats and 35 dogs euthanized due to aggressive behavior or illness.
 - o 25 dogs, 21 cats were transferred to other shelters and rescues
- Field Activity: Officers went out on 625 calls, this quarter, which include the following:
 - 48 Animal Bites
 - o 71 Investigations of Cruelty, Neglect, or Abandonment
 - 136 Loose and Aggressive
 - o 59 Barking
- We have seen an increase in the amount of dogs we are receiving compared to the 2017 2nd quarter report we are up in the intake of dogs by 35. We are finding out we are not the only shelter that is seeing an increase of dogs being turned in this year compared to the last few years. It seems all municipal and private shelters in the state of Michigan are seeing a greater influx of dogs. We have had such an increase of the dogs we had to go to a waiting for owners who want to relinquish their dog or dogs just like we do for cats.
- We are still promoting our adoptable animals on the various websites, Face book, Petfinder.com, Youtube, Instagram, Twitter, etc. We are still working with other shelters that are willing to pull animals when the shelter is filling up or take an animal that needs more care than we are able to provide.
- We participated with the Bissell Pet Foundation Empty The Shelter Program on May 5, 2018. We sent 42 cats and dogs down to All About Animals to be sterilized for this event. The week before the event we had the public come in to see what would be available for adoption. Many of the public decided that they would pay our adoption fees instead of waiting for a chance on May 5th to be able to adopt a dog or cat. What we did have available for adoption that day was adopted. That week alone we adopted out 24 cats and 18 dogs.
- The sterilization program with Dr. Musselman and the BAISD has ended for another year. Twenty animals from the shelter were sterilized by Dr. Musselman during this time.
- Our Support group Furfest Rockin' The Rescues has been helping with people who are short on funds and need temporary help with getting food for their pets.


CENTRAL DISPATCH 9-1-1

- 9-1-1 answered: 5,250 Emergency calls in the month of April; 6,445 Emergency calls in the month of May; and 6,640 Emergency calls in the month of June. In total, Central Dispatch has answered 33,806 Emergency calls for 2018.
- 2. 9-1-1 one employee in the training program during the 2nd quarter of 2018. Currently, one trainee is scheduled to complete the training program in the third quarter of 2018.
- 3. A total of 8,805 Bay County residents have signed up for Smart911. 412 residents have signed up in the 2nd quarter of 2018. 161 9-1-1 calls were made that were associated with a Smart911 profile and Bay County 9-1-1 initiated 37 Smart911 texting sessions.
- 4. 9-1-1 is collaborating with all School Districts in Bay County and all law enforcement agencies in an effort to provide remote access to school building cameras. The aim of the project is providing public safety greater information in response to incidents at school buildings.
- 5. 9-1-1 in conjunction with Emergency Management and Bay County Fire Chief's MABAS Division have undertaken a complete radio template and radio procedure redesign. The project focuses on increased safety and increased interoperability. The anticipated completion is 3rd quarter 2018.

The radio serial numbers and flashcodes have been submitted to the Michigan Public Safety Communications System (MPSCS) for creation of radio codeplugs. Once the MPSCS completes and send Bay 9-1-1 the radio codeplugs, Bay County 9-1-1 and Bay County emergency Mgmt will program radios and train responders in radio use.

A radio training program has been created as part of the radio deployment. All public safety agencies will receive radio training as part of the radio update.



ENVIRONMENTAL AFFAIRS & COMMUNITY DEVELOPMENT

Director's Report

- Worked with the DNR at their request to extend DNR Phragmites Grant for approximately \$121,000 to provide additional treatment for Phragmites in Bay County.
- Interviewed five candidates for the Gypsy Moth Suppression Program Assistant Coordinator position in April, filling a vacancy from an earlier retirement. This position assists in the data collection, monitoring, treatment recommendations, and online mapping locations of invasive pests in order to protect the health and investment of canopy trees in Bay County.
- Presented an update on new site information and progress made for the Linwood Scenic Park Improvements to approximately 20 members of the Linwood Civic Improvement Club at their April 5th Meeting.
- Provided an informational overview of Bay County Shoreline Access Improvements to approximately 30 people at the April 19th Rotary Club Nature Festival in Pinconning.
- Worked with the City of Bay City to facilitate and promote the Earth Day Open House Event on April 20th at the Bay City Waste Water Treatment Plant to provide tours and educate residents that there are no untreated discharges (CSO's) into the Saginaw River, provided a first-hand look at how the treatment system works and the quality performance achieved.
- Attended the May 14th Federal Emergency Management Agency (FEMA) Flood Risk Review Meeting at Bay City Hall to hear about the upcoming new mapping from FEMA and that the new official coastal (bayfront) flood maps will reflect a much smaller area than previously, currently mapped. These new maps will not become the 'official' flood zone maps until about late 2019 when they are finalized, but will result in fewer Bay County landowners being included in the coastal floodway, and will result in a reduction in flood insurance costs.
- Attended the May 14th Meeting of the Friends of Bay City State Park for a review and discussion of shoreline access improvements and ensure progress is maintained for public access development plans at the Bay City State Park.

- Participated in the USACE Wetland Delineation Training May 20th 25th. This 5-day course covered all aspects of wetland delineation, focusing on the procedures outlined by the U.S. Army Corps of Engineers to better assist Bay County landowners and developers understand these complex determinations and rules. The course spent significant time on the criteria necessary to meet the wetland delineation standards for wetland hydrology, hydric soils, and hydrophytic vegetation.
- Speaker at the June 6th Chamber Leadership Bay County Class at Bay City State Park. Presented to approximately 25 people to talk about the natural resources of Bay County and local challenges to maximize public use and access to them.
- Participated in the Saginaw Bay Fish Spawning Reef Restoration Education/Outreach Sub-committee on June 11th to discuss potential outreach and education methods to inform the public on how the reefs became degraded - through soil erosion on land and sedimentation in the bay - and how to prevent that from happening to the restored reefs, with simple practices residents can take to prevent soil erosion, with the creation of a reef project webpage and factsheets.
- Participated in the Michigan Environmental Compliance Conference (MECC) Training on June 12th - 13th to learn about new environmental regulations and compliance requirements that affect Michigan and Bay County.
- Attended the Lake Huron Citizens Fishery Advisory Committee Meeting on June 14th in Clare along with fishing representatives, stakeholders, and organizations concerned about improving the fisheries of Lake Huron for recreational, commercial, and sport fishing. Topics discussed at this meeting included lake trout overharvest issues in Lake Huron, an update on the cormorant issue, a review of the Saginaw Bay walleye and yellow perch fishing regulations for 2018, and an update on the Lake Huron Fishing Roadmap.
- Participated in the Michigan Statewide Public Advisory Council (SPAC) Summer Meeting on June 27th and 28th in Frankenmuth to review how citizens around the state are working to help cleanup and restore environmentally degraded areas.

- Coordination for the approval to partner with the State of Michigan for the creation of 1foot elevation contours from LiDAR data for \$7,479.00. Data to be paid for and split evenly by the Bay County Drain Commission and Bay County Road Commission.
- Organized and held two Bay County-Bay City GIS Workgroup Meetings.
- Maintained data for the Bay Area Fetch Viewer.
- Completed GIS Data and Map Requests at an estimated cost of:

- Coordinated with Bay County Mosquito Control to develop an online map that provides citizens with information on when a particular area of the county was adulticided and an estimated date on when the next treatment might occur.
- Participated on the Central Michigan University Geography Department Advisory Board. Met with faculty to provide information on knowledge and skill sets that are important for graduating GIS/Geography students to succeed in their careers.
- Train new GIS Technician Ryan Smith
- Attended Regional GIS Users Group Meeting in Midland.
- Completed the LUCA Data Review for the upcoming 2020 Census.
- Completed the annual Bay County GIS Tax Parcel Update.
- Began assisting 9-1-1/Central Dispatch led effort to draft a county-wide addressing ordinance. GIS staff is working with representatives from 9-1-1, Equalization, and the City of Bay City.

Gypsy Moth Program

- The Gypsy Moth population continues to be low.
- Egg Masses that were collected from Gibson Township for winter mortality studies. 98% of the eggs hatched so winter 2018 had no adverse effects on the gypsy moth population.
- Gypsy Moth populations across the state had increased significantly with defoliation being reported in many counties in the southern half of the State.
- Calls were received from numerous landowners, counties and University staff asking for information about how to deal with these increased populations.
- Male traps were place at 29 monitoring sites. No moths were noted, or expected, at this time.

Emerald Ash Borer (EAB)

- Treatment plans for finalized with Kinnucan Tree Experts the treat ash trees to protect them from EAB.

- One tree was cut done after being marked but prior to treatment after being hit by a car.
- Reports covering the EAB treatment were aired on WNEM-TV5, Bay TV and several

local radio stations.

Educational Programs

- Staff assisted with environmental education programs for Bangor John Glenn High School, Western Middle School, Handy Middle School, Cramer Junior High school, Verellen Elementary School, and Bangor Lincoln Elementary School at the Bay City State Park Visitor's Center reaching over 1000 local students.
- Staff presented Invasive Species education programs for the
- Clover Bud 4-H Day Camp (15) and Tech Wizards Washington School Summer Program (6) with 21 participants plus 10 older youth and adult chaperones.
- Invasive Species update was presented to 26 Bay City Noon Optimist in May.
- Staff provided invasive species information at the Free Fishing event held at Bay City State Park.

Michigan Green Schools Initiative

- Schools were sent information priming them for participating in the Michigan Green Schools Initiative next year.
- Energy saving information and Grant application information was passed on to seven (7) participating schools.

Mosquito Control

- A cool spring delayed the start of aerial treatment until April 23, about a week later than usual. Treatment of 49, 834 acres of flooded woodlots was completed in 6 days. Overall treatment results were successful with over 96% mortality in test sites.
- The signed DEQ Scrap Tire Grant contract was submitted providing funding up to \$8,000 towards 2 scrap tire recycling events hosted by Mosquito Control this summer. The first tire drive of the season was held June 2 at Mosquito Control with 1,039 tires collected.
- Staff attended a MSU Extension-sponsored Pollinator Health meeting on April 17. This
 meeting promoted positive discussion between multiple stakeholder groups including
 beekeepers, researchers, and pesticide applicators on methods to improve pollinator
 health and increase pollinator habitat.
- Staff participated at a mosquito life cycle exhibit at the State of Michigan Earth Day
 Event in Lansing April 19 sponsored by MDARD, DEQ, and DNR. This exhibit included
 interactive displays and informational videos on the mosquito life cycle as well as
 methods to reduce mosquito breeding sites to teach more than 2,300 students and
 parents about responsible decisions involving the environment and natural resources.
- Staff represented Mosquito Control with a display at the Bangor Green Team Earth Day event at Bangor Township Hall on April 21 highlighting the mosquito life cycle, source reduction, and biological controls used in mosquito control.
- New Master Mechanic Chad Milkowski joined Mosquito Control April 30 and has been

doing a great job maintaining and improving our fleet. Chad has 15 years of work experience maintaining vehicles and small engines.

- Staff completed mosquito presentations to nearly 700 first grade students in the Bay City Public Schools. These presentations included information about life cycles, habitats, disease, and surveillance tools. Students also visited hands-on stations to learn about aquatic insects through crafts, puzzles, and games. This educational opportunity not only teaches children about mosquitoes, but meets STEM benchmarks for first graders in the school system.
- Two staff members completed Storm Water Pollution Prevention Plan training and earned certification for storm water compliance. This training helps staff identify and prevent potential pollutant sources in order to reduce storm water pollution, as well as training on spill prevention and clean-up.
- Two training sessions were held for all 30 seasonal employees on May 11 and June 11.
 These day-long training sessions cover proper pesticide application requirements,
 integrated mosquito management, Bay County work rules, and the various job
 functions at Bay County Mosquito Control.
- Michigan Department of Agriculture and Rural Development hosted a certified pesticide applicator examination for 10 new staff members at our facility on May 14.
- Our full seasonal staff was brought on board May 14. Larviciding crews began with training new staff and treatment of standing water in woodlots and backyard inspections. Adulticiding crews began with training new staff, establishing spray routes, and a treatment focus on areas with late emergence of spring species of mosquitoes.
- A couple rain events with over an inch of rain were experienced in early to mid-May leading to the first increase in adult mosquito populations. The spring species *Aedes canadensis* emerged from woodlots, *Culex* species from woodlots, tires, and containers, and *Ae. vexans* in fresh rainwater sites including roadside ditches.
- Early June saw the treatment of approximately 14,000 catch basins throughout Bay County with naturally-occurring bacterial products.
- High adult counts of Coquilletidia perturbans, the cattail marsh mosquito, have been
 collected throughout the month of June, with highest counts along the Saginaw Bay
 shoreline. CDC Trap counts numbered in the mid-hundreds to low thousands in these
 areas. Adulticiding treatments continued to focus on these areas through the entire
 month of June.
- Staff presented a program on the mosquito species *Coquilletidia perturbans* at the Pinconning Rotary Club meeting on June 14.

- Biology staff implemented the use of a new Catchmaster Ovi-Catch trap to increase disease surveillance in areas where *Culex* mosquitoes would likely breed. The trap is designed to catch female mosquitoes looking for a suitable site to lay eggs.
- Two rain events at the end of June collected 1-2" of total rainfall for most of Bay County requiring some ditch treatments. Dry ground conditions at the time led to quick absorption, however, an expected increase in *Aedes vexans* will likely occur in 7-10 days as a result.
- As of June 30, nearly 10,000 mosquitoes have been sent to MSU for testing of West Nile virus and Eastern Equine Encephalitis disease presence with 0 testing positive.
- As of June 30, 4 birds have been tested in-house with the Vector Test for testing of West Nile virus presence with 0 testing positive.

- Attended PASER Training in Mount Pleasant.

- Participated in two Asset Management Coordinator's Conference Calls.
- Began PASER collection for Bay County Federal-Aid eligible roads.

HEALTH

Administration

Since 2013, the Bay County Health Department Administration has implemented a Strategic Plan to provide a framework for future growth and direction. Key staff from the Health Department was assembled to assist on the steering committee, which is also known as the FAB TEAM (short for Forever Achieving Better, Together Everyone Achieving More). The new BCHD Strategic Plan builds upon previous work from 2013-2015 and has eight overarching goals:

- 1. BCHD will create an environment that values and respects all customers and employees.
- 2. BCHD will promote our programs and services in the community.
- 3. BCHD will provide responsible fiscal management for its programs and services.
- 4. BCHD will utilize the latest technology to reach a broader audience.
- 5. BCHD will assure a competent public health workforce.
- 6. BCHD will create a welcoming environment conducive to meeting client needs.
- 7. BCHD will seek opportunities to expand programs and services.
- 8. BCHD will broaden and strengthen partnerships with community organizations.

The FAB TEAM is working on a detailed plan that encompasses current efforts to modernize programs and physical environments and determine metrics to measure success.

Key accomplishments during this period include:

The Bay Community Health Clinic has moved into year three of a cooperative clinic project with Saginaw Valley State University. The clinic continues to focuses on persons with multiple chronic conditions, who are uninsured/underinsured, especially veterans and persons with behavioral health issues. With subsequent grants funded to expand services, the Health Department is working with the University and Bay Arenac Behavioral Health expanding primary care services for residents who receive treatment for mental health at BABH. With the assistance of, Christine Chesny, several changes have been made to ensure the efficient operations of the clinic beyond the expiration of grant funding. Via the clinic, the Health Department has submitted attestation to demonstrate Meaningful Use requirements including, but not limited to patient portals, HL7 interfaces with State Databases, HEDIS reporting requirements and patient notification beginning for a 90 day period, starting October 1 and ending on December 31, 2017. If this attestation is approved by the Michigan Department of Community Health, the Health Department will be eligible for additional meaningful use funds in 2018. A definitive answer will be made regarding the eligibility of funds in the second guarter of 2018.

- 2. The Health Department has met with representatives from McLaren Bay Region, Mid Michigan Community Action Agency, United Way, and the Great Start Collaborative to begin preliminary planning for an upcoming community health assessment, starting in the summer of 2018. Bay County has received a \$10,000 grant from the Bay Area Community Foundation to help fund the Bay County Community Health needs assessment in 2018.
- 3. The recent renovation that has improved security and privacy concerns at the health department facility is completed. An Open House to demonstrate the new security features will be held in August or September of 2018.
- 4. My Community Dental Centers has recently undergone a reorganization of its Executive Staff, but is still committed to expand into Bay County, where dental services for Medicaid eligible residents are limited. It is anticipated that MCDC will open, at no expense to county tax payers, a six seat dental facility is now anticipated to take place in late 2018/Early 2019.
- The Health Officer continues to work with the Great Lakes Bay Health and Economic 5. Initiative The Health Officer is the lone representative for public health in the four county area of focus (Bay, Saginaw, Midland and Isabella Counties.) Currently he is the co-Chair of the Regional Preventive Care Committee, working with representative from major hospitals, mental health, education and business to formulate a regional plan for prevention services. Children's Special Health Care Services (CSHCS)

CSHCS provides supplemental insurance benefits and services of a registered nurse to children who have a qualifying medical diagnosis. A child is invited to enroll whether they have private insurance or a Medicaid Health Plan. Staff assists families to navigate the medical, health insurance and educational world of the child with medical special needs. These services promote optimal functioning for the child and family.

The program is funded for two FTE nurses and one 0.5 FTE clerical. It is also supported by a MDHHS mini-grant of \$10,000 to hire a CSHCS Parent Liaison to provide outreach activities to CSHCS families including:

Personal Health Services (Family Planning)

The former Family Planning Clinic and STI Clinic have been combined into the newly establish Personal Health Family Planning Clinic. The Clinic was redesigned to allow for 2 clinical rooms and staffing increased to have a nurse practitioner on site 2 days a week and the nurse available 5 days a week. The client response has been positive with many STI clients who in the past may have only sought STI services are now enrolling in the Personal Health Family Planning Clinic, a Title X Clinic, as they see the benefit of receiving comprehensive sexual health and contraceptive services the clinic can offer. As a result of the combined clinic STD testing will no longer be itemized in this quarterly report and is included in the numbers below.

HIV/AIDS Testing & Outreach

Beginning fiscal year 2017-2018, MDHHS has provided funding for HIV Outreach and Testing.

- This includes setting up HIV education and Rapid HIV testing events and finding Bay County HIV/AIDS clients who have been diagnosed anywhere from the 1980's and on and who have since disappeared from known medical care follow up.
- Rapid HIV testing is now available by appointment every Wednesday at the BCHD.
- MDHHS recommends HIV testing as a standard of care for all clients. Due to the extensive mandatory counseling when providing HIV testing, it was determined it is not possible to provide Rapid HIV testing during a scheduled Personal Health Family Planning or Bay Community Health Clinic visit, but that if client is willing to wait they could be seen same day if HIV nurse is available or reschedule for alternate time to see HIV nurse for Rapid HIV testing. Serum HIV testing is always available Discussion is occurring about possibility of providing the outreach information & condoms at local bars.
- This quarter all HIV testing was done at BCHD. Number of clients tested for HIV this quarter: 29, 13 males (1 court ordered) and 16 females. All HIV results were negative.

 Healthy Homes and Lead Poisoning Surveillance System (HHLPSS) is the state wide site for the reporting of blood lead levels for all children in Michigan. It assists the local health department (LHD) by identifying children in their jurisdiction who have an

elevated blood lead level (EBLL). These children are eligible for PHN case management services. Kelly Dore, RN, BSN coordinates the program.

- These 5 programs combined have saved the county over \$700,000 for the quarter by supervising offenders in the community with treatment. These programs assist with jail overcrowding and bed space utilization as well.
- One of the objectives for Community Corrections is to reduce the overall Prison Commitment Rate to 15% or below, this is the new goal for 2018. Bay Co did not meet this goal. Prison Commitment Rate for 2017 is 23%, which is a 7 point increase from 2016. Group 2 Straddle cell rate also went up to 34.5%, which is a 9 point increase from last year. It may be due to the Heroin epidemic that has plagued Bay Co. The information above is related to people that were sent to prison. Bay Co will continue to try and keep the prison commitments low by utilizing the treatment programs funded through PA511.
- Throughout this quarter, the Manager has attended Drug Treatment Court Team meetings and TRICAP Board Meetings. The Manager also hosts the quarterly CCAB meetings with Community Corrections board members.

Director's Report

• The mission of Michigan State University Extension is to help people improve their lives through an educational process that applies knowledge to critical issues, needs, and opportunities. For more than 100 years, MSU Extension has helped grow Michigan's economy by equipping Michigan residents with the information that they need to do

their jobs better, raise healthy and safe families, build their communities and empower our children to dream of a successful future.

- Over the past year, Michigan State University (MSU) Extension partnered with Bay County to continue strengthening youth, families, businesses and communities. Your MSU Extension staff members, grounded in local relationships, serve by bringing the university's research and resources to provide outreach and education in the areas Bay County residents need it most.
- We're passionate about serving Bay County and are looking forward to a new year.
 Thank you for your continued support of MSU Extension and for partnering with us to make a difference.

Michigan Sea Grant Programming

- As an Extension Educator with Michigan Sea Grant, I have been helping further connect communities around the Saginaw Bay region to the Great Lakes this spring and summer. In April, Michigan State University Extension and Michigan Sea Grant, in partnership with fisheries agencies and stakeholder organizations, hosted the Lake Huron Regional Fisheries Workshops. At the workshop focused on Saginaw Bay, over 80 participants learned about the status of the fishery and current research in Saginaw Bay and Lake Huron. As a new member of the MSU Extension and Sea Grant team, I was happy to attend and provide logistical support at the meeting. Additionally in June and July, I hosted a series of webinars for local decision makers and planners to raise awareness about the impact of extreme storms and flooding while also increasing understanding about strategies communities can take to be more resilient to these hazards. These webinars were recorded to more broadly share content, and in August, there will be a Resiliency Summit to share more information, network, and discuss the steps. The webinar and summit topics were selected from surveys that area decision makers and planners completed in 2015 related to extreme storms and flooding. This project has been supported by the NOAA Coastal Storms a variety of regional partners including Bay County Emergency Management Division, East Michigan Council of Governments, Midland County Office of Emergency Management, and the Saginaw Bay Coastal Initiative.
- I also supported regional youth development through place-based stewardship education opportunities. In the school year, I provided programming for area schools as they released fish the students had raised in the classroom, and I have met with teachers to plan efforts for 2017-18 school year. I also worked with MSU Extension's 4-H Tech Wizards' Program, where Handy Middle School Youth developed a display to highlight their perceptions of the June 2017 flooding in Bay County. This display will be showcased at the Resiliency Summit in August. Beyond the classroom, I connected with area youth at the Bay City State Park's Free Fishing Day, where youth learned more about fishing through a variety of hands-on activities. This summer, I will partner with MSU Extension 4-H Program and other area partners to host youth the Saginaw Bay 4-H Fishing Camp and Invasive Species 4-H Youth Workshops. These workshop help

youth better understand Great Lakes issues while also allowing them to serve as leaders in the community today by completing a variety of stewardship efforts.

4-H Children and Youth Program

- I am currently in the process of writing new activities, 15 focused on healthy living and 15 focused on early childhood, to be included in the Heads In Hearts In materials available for staff and community partners to download from the MSU Extension website and use for free. Current science activities and staff guide are being updated as well. Heads In Hearts In family enrichment program encourage families to use their minds (putting their "heads in") as a tool to expand their knowledge around a variety of topic areas. MSU Extension says that by creating a shared educational experience, the family unit will work, grow and learn together, putting their "hearts in" to the process. In 2019, an additional 30 activities will be written and added to the current Heads In Hearts In materials. The new activities will focus on math and mindfulness.
- MSU Extension has been using the SAFE: Screening Applicants for Effectiveness. Guidelines to Prevent Child Molestation in Mentoring and Youth Serving Organizations training to build skills in staff members who work with children, youth and/or volunteers. Although 90 MSU Extension staff have already been trained MSU Extension administration is asking that all faculty and staff members who work with children, youth and volunteers have the skills and knowledge to prevent child molestation in our programs. I am one of ten individuals who has been identified to be trained as a trainer in this content. I will be trained in September and begin working with faculty and staff immediately.
- Our local partnerships have continued to raise success in children, youth and families. Over 163 individuals attended a hands-on, educational STEAM night at Linsday Elementary School in April where 15 activities were offered for families to participate in. Holly and I completed our in-school science/math series at Hampton Elementary School with three 2nd grade classrooms. Topics this school year included fractions, plants and soybean seed necklaces, landforms, measurement and regrouping. MSU Extension also partnered with Linsday Elementary to offer Successful Summer kits. The kits were given to every child in the school and provided educational materials and supplies to keep the kids engaged in learning over the summer. MSU Extension educational materials and support to the items purchased. Topics covered in the kits included: math, science, literacy, nutrition, physical activity and mindfulness.

4-H Programming

- 4-H was busy with ending the Archery season with having a banquet for all participants. Families enjoyed a potluck dinner, while the youth got to enjoy a fun shoot which included shooting cards on a carousel, balloons, 3D animals, Ping-Pong balls, etc. We had 50 plus youth participate in Archery this year. Every year our club keeps growing.
- I also helped Jodi Schulz, Extension Educator with family enrichment programming at Hampton Elementary. We work with the three 2nd grade classrooms. We help the teachers with introducing the kids to subjects like math, science and literature. We do activities like, make soybean necklaces, identify plants parts out of vegetables

(celery-stem, carrots-roots, lettuce-leaves, etc), use pull apart licorice and fruit loops to help them understand and make fractions.

- Continued planning efforts with partners for Saginaw Bay 4-H Fish Camp. Saginaw Bay 4-H Fish Camp in Monday, July 16th Thursday, July 18th. We have everything planned and all volunteers and partners lined up for the event.
- I continue to offer support to my volunteers through the 4-H Livestock Association, 4-H Horse Council,
 4-H Advisory Council and Expansion and Review. I presented to the Morning Rotary Club about what is happening and upcoming in 4-H. I continue to attend Noon Optimist

meetings.

- Our 4-H youth were able to attend a wonderful Lamb workshop. The youth spent all day working with their lambs learning how to properly wash their lambs, shear their lambs, dry their lambs and they also got to work with their lambs in the show ring. At the end of the workshop they all participated in a showmanship class to show others what they learned during their time at the camp.
- I continued to prepare and plan for Cloverbud Camp; June 25-28. Cloverbud's are youth who are 5-8 year olds. They all got to learn about worms and vermi-composting, self-esteem flowers, made stomp rockets and got to launch them to see how far they went. They also got the opportunity to paint pottery and Painterly Pottery. We also visited the Commissioner's Chambers to see where all the meetings happen and what they discuss during those meetings.
- I attended Exploration Days with the youth and adult volunteers. Exploration Days is held at MSU campus and it's where youth get to spend 3 days living and experiencing campus life. They all stay in the dorms, each in the dorm cafeterias, attend college course and they learn how to navigate MSU Campus. Youth can attend sessions like, horse behavior, animal science, astronomy, kayaking, paddle boarding, baking, sewing, international garden chef and so much more!

4-H Tech Wizards Program

- The Bay County Tech Wizard program has had a busy, productive and exciting quarter. Handy Middle School Tech Wizards worked with the Michigan Sea Grant program to create a display for their Resiliency Summit in August. This display highlights how the floods of 2017 affected them personally. The display featured poems, pictures, drawings, feelings and statistics. Handy's Tech Wizards program concluded May 28th.
- Washington Elementary Tech Wizards made magnetic slime, blew up marshmallow peeps in the microwave, weighed and measured trail mix, learned about and traced the skeletal system, gained knowledge in basic geometry and participated in an Earth Day activity, coloring and designing recyclable shopping bags for the City Market. The Tech Wizards took part in a brainstorming session for future programs. The students listed over 50 topics/classes that they would like to have presented to them. These ideas included: computer coding, the brain and its function, gaming, interior design, light/electricity, baking, potions, chemistry, mechanical drawing, martial arts, interviewing skills and drones.

- This quarter the Bay Area Family YMCA after school program participated in Tech Wizards. 20-30 students per session, age 5 - 12 have participated in the Tech Wizard program. The participants are very willing to learn more about STEM especially via hands-on lessons.
- This summer, the Tech Wizard program continues at Washington Elementary with special programs bringing in area experts in Disability Awareness, Invasive Species and Mammals. A special trip is planned to the City Market to learn more about locally grown products and locally manufactured goods as well as information on organic foods. A trip to Eden Fields Assisted Living will have students and residents working together on a project and sharing a lunch meal. The YMCA summer camps - 10 weeks will feature a Tech Wizards program every Thursday afternoon. The Bay County Community Center will have six sessions of STEM related education presented by MSU Extension.

Supplemental Nutrition Assistance Program (SNAP-Ed)

- Health and Nutrition Institute was busy in the Pre-K classrooms in April and May. In April, I was involved with SMART Girls at Boys and Girls Clubs, Great Lakes Bay Region. SMART Girls is a curriculum for girls 8-12 years, empowering life skills and healthy, active lifestyles.
- Also, 2 senior nutrition series at Center Ridge Arms and Bradley House. Monthly presentations are ongoing at the Good Samaritan Rescue Mission.
- In July and August, I will be programming in Midland County at Camp Iknowme. This is a 6 week camp for 13-15 year old teens who are involved in both the juvenile justice and community mental health systems. Also in Midland, nutrition programming at Cleveland Manor, a senior high rise.
- Summer nutrition series at Boys and Girls Club in Pinconning. Approximate 40-45 youth will be present weekly.
