

# REPORT TO THE COUNTY EXECUTIVE THIRD QUARTER, 2019

The following reports for the 3rd quarter of 2019 are presented to the County Executive:

## **ADMINISTRATIVE SERVICES**

- Assisted in daily operations at Animal Control due to the manager retiring in May of this year.
- Attended MMRMA annual fall event.
- Worked with MMRMA and various departments regarding automobile and property damage claims.
- Assisted in coordinating various events at the Animal Services & Adoption Center including a retirement party, school visits and tours, as well as an outreach event at Bangor Christa McAullife Middle School.
- Schedule and plan for upcoming events at the Animal Services & Adoption Center which will include local businesses coming to assist walking dogs, cleaning, and learning about the shelter.
- Planned an upcoming 5s project at the Animal Shelter.
- Working with a local business on the possibility of a sign donation for the Bay County Animal Services & Adoption Center building.
- Assisted the Veterans Offices in coordinating financial processing expenditures through & Sailors Relief and Veteran Transportation Services.
- Finalized the completion of the newly renovated Veteran Affairs office on the 1<sup>st</sup> floor of the Bay County building.
- Resolved a number of constituent inquiries and communications made to the Administrative Services office.
- Met with Animal Control and the Prosecuting Attorney's office.

- Examined and initiated updating standard operating procedures at the Animal Services building.
- Worked with various County offices in processing Freedom of Information Act (FOIA)
  responses for the Second Quarter. Many responses required several hours of work as
  they were sizeable in nature. Most requests required receiving records from 911
  Dispatch, the Sheriff's Office, The Health Department, as well as Animal Control.
- Met and discussed various Soldiers / Sailors Relief items with staff.
- Attended the Veteran Affairs Department meetings in July, August, and September.
- Completed the yearly MMRMA renewal.
- Finalizing the agreement with the Saginaw Correctional Facility and Bay County to utilize their dog training program.
- Observed a monthly visit by a local veterinarian, Dr. Francke from Bay Animal in which various dogs and cats are evaluated and vaccinated.
- Answered questions and assisted in social media for Animal Services.

#### **Animal Control**

The Shelter took in 166 cats, 168 dogs, 6 rabbits, 2 goats & 4 Guinea Pigs for a total of 346 animals.

- Owners claimed 4 cats and 71 dogs.
- We adopted out 72 cats, 43 dogs, 6 rabbits, 2 goats, 4 Guinea Pigs
- 16 cats and 20 dogs were euthanized per owner's request.
- 4 cats and 5 dogs euthanized due to aggressive behavior or illness.
- 28 dogs and 44 cats were transferred to other shelters and rescues

Field Activity: Officers went out on 845 calls, this quarter, which include the following:

- 75 Possible animal Bites
- 63 Investigations of Cruelty, Neglect, or Abandonment
- 215 Loose and Aggressive
- 110 Barking
- We are promoting our adoptable animal on the various websites, Face book, Petfinder.com, Youtube, Instagram, Twitter, etc. We have our own Facebook page that is monitor daily. We are still working with other shelters that are willing to pull animals when the shelter is filling up or take an animal that needs more care than we

are able to provide.

- We have started a dog walking program where the public can come in and walk a dog in the fairgrounds. Walkers are evaluated to make sure they are able to handle the dogs before they are allowed to walk them. This program has been so popular that we have birthday party, a retirement party and even a high school come to walk dogs at the shelter in the recent weeks.
- We have started some enrichment programs at the shelter. We have purchased or have had donated to us Kongs which are filled with peanut butter or yogurt and then frozen. Each dog is given at Kong before closing to be able to enjoy overnight.
- Bangor Township is once a week having a shelter dog at their offices it has been highly successful.
- We are seeing a high request of owners wanting to turn in their pets. We currently have a waiting list of 19 dogs and over 200 cats waiting to come into the shelter.
- On October 12, 2019 we will be having the second Empty the Shelter event for the year. We will have about 15 dogs and over 40 cats that will be available for adoption.
- We are still waiting to see whether or not there will be a sterilization program with the Veterinary Tech Program at the BAISD. We are hoping to hear by the end of October.
- We have used all of the \$3000.00 grant from the Department Of Agriculture grant that was awarded to us for 2019 for sterilization of shelter animals. We will be applying again for the 2020 grant and we will be asking for more money to continue sterilizing animals at the shelter.
- We have a few events coming up to help promote the shelter including a trick or trunk for Halloween and a nail event

## CENTRAL DISPATCH 9-1-1

- 1. 9-1-1 answered: 7,721 Emergency calls in the month of July; 7,341 Emergency calls in the month of August; and 7,170 Emergency calls in the month of September. In total, Central Dispatch has answered 58,638 Emergency calls for 2019.
- 9-1-1 filled three Dispatcher vacancies in the 3<sup>rd</sup> quarter, 2019. Two employees are in various stages of the training program. One vacancy was filled by a returning employee.
- 3. 10,306 Bay County residents have signed up for Smart911. 444 Residents have signed up in the 2<sup>nd</sup> quarter of 2019. 112 9-1-1 calls were made that were associated with a Smart911 profile and Bay County 9-1-1 initiated 26 Smart911 texting sessions.
- 4. 9-1-1 in conjunction with Emergency Management and Bay County Fire Chief's MABAS Division have undertaken a complete radio template and radio procedure redesign. The project focuses on increased safety and increased interoperability. The project is nearly complete with only some minor updates to complete. The completion of this project is the culmination of near 18 months of planning and effort.
- 5. Continued to work with Buildings & Grounds and Information Systems Division to enhance the resiliency of the electricity service to the 8<sup>th</sup> floor of the County Building.
- 6. Continued to prepare for Text-to-911 implementation. The text-to-911 software has been installed and 9-1-1 staff has been trained in the use of the software. 9-1-1 plans to go live in the 4<sup>th</sup> quarter of 2019.
- 7. Coordinated the installation of redundant PFN fiber connection between Bay 911 and Midland 911. This is in preparation for the 4<sup>th</sup> Quarter onboarding Saginaw, Isabella and CMU onto the GLB phone system.
- 8. Conducted an upgrade of the West Viper 9-1-1 phone software.
- 9. Began upgrading the 9-1-1 Computer Aided Dispatch (CAD) system. A major component of the upgrade is access to RapidSOS software within the CAD. RapidSOS will allow for enhanced location services when residents call 911. The upgrade is scheduled for completion on October 14<sup>th</sup>.

#### **Emergency Management**

- 1. Chaired 2 Local Emergency Planning Committee meetings, and 1 Local Planning Team meeting.
- 2. Participate in 3 Region wide 800Mhz radio tests.
- 3. Participated is planning session with the USCG and local partners for upcoming Tall Ships Festival.

- 4. Organized a webinar and face-to-face meeting with the USACE, Bay County Executive, Bangor Township and the City of Bay City to address potential flooding risks along the Saginaw Bay, Saginaw river and the Kawkawlin river. This led to Bay County receiving 40,000 sandbags from the USACE to be distributed to municipalities along those waterways for flood prevention.
- 5. Attended meetings with the Active Assailant Task Force to discuss future steps. Currently planning a train-the-trainer session for individual responder agencies to send trainers to so that the county-wide response plan can be continually taught at each agency.
- 6. Organized monthly meetings of the Hazard Mitigation Plan Advisory Committee. The hazard identifications, ranking of hazards, risk assessments and goals and objectives have all been completed. We are currently working on evaluating the past identified hazard mitigation projects to see which ones have been completed and which ones will remain in the plan.
- 7. Presented Smart 911 information at the Riverside Senior Dining site.
- 8. Met with Bay City Public Schools, Bay Arenac ISD Career Center, Bay City Department of Public Safety, Bay County Sheriff's Department and Bay County Central Dispatch to discuss notification procedures to school administrators during high risk incidents.
- 9. Met with senior members of the Bay County Auxiliary Communications Group to discuss the recent release of the credentialing process from the State of Michigan.
- 10. Submitted quarterly reports to the State of Michigan per the FY19 EMPG grant agreement.

#### **Director's Report**

#### Neighbors of the Bay Magazine

There is a new local magazine being created called *Neighbors of the Bay* that will highlight Bay County, focusing on articles that are of interest to high wage earners in the area. The Director of the Environmental Affairs & Community Development Department has been working to coordinate information and writing articles for the new magazine. The first issue will come out in October 2019.

#### Route Bay City

The Director of the Environmental Affairs & Community Development Department met with members of Route Bay City and was interviewed about the Rock Reef Project. Fishing in Bay County is a \$38 M industry in the Saginaw Bay alone (95% sports/5% commercial).

#### Fish Spawning Rock Reef Restoration:

The Director of the Environmental Affairs & Community Development Department is happy to announce that the Fish Spawning Rock Reef Restoration Project has been moving forward and is in the construction phase. The two acre rock reef will be out in deeper water of the Saginaw Bay at the Coreyon Reef site. The restored Saginaw Bay Rock Reef will help create some diversity for fish habitat in the Saginaw Bay. Fishing in the Saginaw Bay is a lucrative endeavor with \$35M in sports fishing and \$4M in commercial fishing to make it a \$39M industry.

  The Director of the Environmental Affairs & Community Development Department
  developed and submitted a grant proposal on behalf of the Saginaw Bay Lake Sturgeon
  Recovery Foundation to apply for grant funding from the East Michigan Council of
  Governments (EMCOG) to help in the recovery of Sturgeon in the Saginaw Bay.
- \$27,000 Grant Award from Saginaw Bay WIN for Linwood Scenic Access Site
  The Director of the Environmental Affairs & Community Development Department
  developed and submitted a grant proposal on behalf of Linwood Civic Improvement
  Club to apply for grant funding from the Saginaw Bay Watershed Initiative Network
  (WIN) for improvements to the Linwood Scenic Access Site Improvement Project. She
  worked to provide coordination with Fraser and Kawkawlin townships and the Linwood
  Civic Improvement Club to facilitate the project. The Linwood Scenic Access Site
  Improvement Project was awarded a \$27,000 grant from the Saginaw Bay Watershed
  Initiative Network (WIN). The Board of Commissioners has authorized to accept the
  grant award from WIN. Laura will be providing her time as some of the match for this
  grant and Bay County will administer the \$27,000. The total cost of the project will

#### WIN State of the Bay Conference.

The Director of the Environmental Affairs & Community Development Department served on the Panning Committee and presented at the September 26th State of the Bay Conference held at the DoubleTree in Bay City. Every two years, the Saginaw Bay Watershed Initiative Network (WIN) and its partners provide a focus on Saginaw Bay and its Watershed through the State of the Bay conference. The purpose of the conference is to highlight educational initiatives, restoration, community development and conservation activities occurring across the watershed and related to our river systems and coastal areas, as well as provide an update on research and emerging topics of interest. Hear from researchers, educators, nonprofits, and more on three tracks of focus: Environmental Education, Community Development, and Watershed Issues and Management.

## Completion of MDNR Phragmites Grant

The Director of the Environmental Affairs & Community Development Department is happy to announce the successful completion of the Department of Natural Resources (DNR) Phragmites Grant. The coordination of aerial spray treatment and mechanical (mowing) treatment of the Phragmites along the shoreline of the Saginaw Bay in Bay County has helped to reduce Phragmites stalks and open up the shoreline for both visual access and physical access. Phragmites are an invasive and difficult plant to eradicate. The completion of this grant work fulfills the commitment of Bay County to help restore socio- and cultural connections to the Saginaw Bay and represents an active partnership from around the bay including the Saginaw Chippewa Indian Tribe, Hampton Township, Bay County, Tuscola County Economic Development Corporation, Saginaw County Conservation District and the Michigan Department of Natural Resources. This grant was funded in part with funds from the Michigan Invasive Species Grant Program through the Michigan Department of Natural Resources (MDNR), Michigan Department of Environmental Quality (MDEQ), and the Michigan Department of Agriculture and Rural Development (MDARD).

#### Partnership for the Saginaw Bay Watershed

The Director of the Environmental Affairs & Community Development Department is now the Chair of the Partnership for the Saginaw Bay Watershed (PSBW). The Partnership for the Saginaw Bay Watershed was formed to coordinate efforts and monitor progress toward restoration goals with an ultimate goal of removing the Saginaw River and Bay from the list of AOCs throughout the Great Lakes. The PSBW is the non-governmental oversight organization created to coordinate the information and activities regarding the Saginaw Bay Watershed Area of Concern. The group has been dealing with the beach closures and water sampling. The Bay County Health Department notification system for beach closures is a bit extreme as they send notification all over the State, which gives our area a bad reputation and deters people from coming to our beaches. State Law requires three kinds of notification: Users of the beach (local area), that it be placed on Beach Guard (an online State website), and posted on the beach (via sign notification). They are working with the Health Department to make sure the message is clear and an accurate representation of what is happening at our beaches. The group is focusing on water quality sampling.

#### Harvest Hustle

The Director of the Environmental Affairs & Community Development Department has been working with The Bay Are Community Foundation to facilitate the 1<sup>st</sup> Annual Harvest Hustle Race that took place on September 29<sup>th</sup>. This event was created to support the Trail Maintenance Fund. County staff was eligible to be reimbursed through the Bay County Wellness Program for their participation in the Harvest Hustle races.

The Director of the Environmental Affairs and Community Development Department served on the planning committee and attended the Bay Area . . . on the Grow event on September 27<sup>th</sup> at Uptown in Bay City. The event highlighted our farming community and discussed ways we can support and showcase agribusiness.

#### **Gypsy Moth Program**

• Gypsy Moth: throughout the summer staff monitored the Gypsy Moth population using pheromone traps that attract male Gypsy Moths. The traps were checked eight times with peak activity occurring during the first week in August. Initial flight of the male Gypsy Moths was noted on July 9th while traps were being diploid and continued into the first week of September when the traps were retrieved. Overall numbers indicate that the Gypsy Moth population is higher than in 2018 though in areas where treatment was done, the numbers are down in both official and private monitoring traps. The table to the right summarizes the results of Male Gypsy Moth Trapping in 2019.

No defoliation of trees was noted in the County. Delimiting surveys will be conducted during the fall and early winter to determine if local populations have reached outbreak level which will require treatment next spring.

In an effort to increase awareness of the program and to better connect with property owner where Gypsy Moths are likely to damage trees, a request to allow fall monitoring for Gypsy Moths on individual properties was sent to approximately 4,800 landowners. Initial indications from the response are that most landowners

are willing to allow Gypsy Moth monitoring on their land and that

they continue to support the program. Most objections were due to concerns related to the opening of deer hunting season.

• Emerald Ash Borer (EAB): Field surveys to evaluate the success of Emerald Ash Borer (EAB) treatment operations and the health of the remaining ash trees in our inventory were started in

September with initial results showing that the majority of trees continue to grow and thrive. Plentiful water this summer also appears to have helped the trees to hold onto their leaves longer than usual which should allow them to continue to grow well into late fall and winter. The picture inset shows a snapshot of the ash tree inventory map. The different symbols for the trees indicate healthy trees, those that are marked for removal and those that have already been removed. Summary reports on the ash tree inventory will be developed and sent to managing agencies later in the fall when time allows.

• Educational Programs and Staff Training: Staff members attended live and web based training programs about ongoing research on the Gypsy Moth, EAB and Urban Forestry and tree health care. In September they attended the MiCAMP GIS conference to learn more about how to utilize geographic based information to track, monitor and manage more efficiently and accurately. Jeremy also did a presentation about the value of using Arc-Collector to collect data for the ash tree inventory work and Gypsy Moth monitoring.

#### **Mosquito Control**

- July transitioned into warmer, drier weather than we had seen the previous couple months. The lack of precipitation lasted into the end of August. As a result, numbers of our floodwater mosquito, *Aedes vexans*, were minimal from July through September. This mosquito emerges as a result of standing water from heavy rains and is the primary nuisance mosquito in Bay County. *Ae. vexans* typically account for 70% of light trap collections, however in July they averaged 20%, and in August, 4% of the total catch due to the dry weather.
- Counts of *Coquillettidia perturbans*, the cattail marsh mosquito, saw high numbers along the Bayfront and marsh areas for most of July and August. CDC Trap collections in July amounted to 19,611 *Cq. perturbans*, 79% of the trap collection. This species of mosquito emerged later than last year (early June in 2018), likely due to the cooler temperatures in May and June 2019, delaying most emergence until July.
- Along with Cq. perturbans, Anopheles species mosquitoes, found in permanent water sites with vegetation, made up the bulk of trap count numbers in July and August. This is a trend we have seen for several years with higher lake levels flooding more vegetated areas, and lower summer rainfall events.
- Bay County's first West Nile virus-positive bird was collected in Bay City on July 9. A
  press release was sent out encouraging residents to use personal protective measures
  to prevent mosquito bites. West Nile virus has been found in birds in Bay County every
  summer since 2002.
- In Bay County, 3 of 9 birds tested positive for West Nile virus. Of the 594 mosquito samples (containing 18,837 female mosquitoes) that have been submitted to Michigan State University for disease testing, 13 of the samples tested positive for West Nile virus. In comparison, 2018 saw 31 birds and 16 mosquito samples testing positive.
- Statewide, West Nile virus was reported in 5 human cases, 4 blood donor cases, 11 birds, and 54 mosquito samples as of September 30. These are significantly lower statistics for West Nile virus in Michigan than in 2018.

- A human case of West Nile virus in Bay County was confirmed by the Health Department on September 27. Mosquito Control followed up the report with increased surveillance, adulticiding, and larviciding in the area to lessen risk of transmission.
- 343 mosquito samples containing 6,110 mosquitoes were submitted to Michigan State University for Jamestown Canyon virus (JCV) testing. Although positive JCV cases were found in Bay County in 2018, as of September 30, none have tested positive this year.
- Mosquito Control conducted outreach on disease activity and personal protective measures through mLive, WNEM interviews, and Bay County's Facebook page.
- Treatment activities from late August through September focused mainly on disease prevention in high risk West Nile virus areas as well as treatment in cattail marsh areas where higher mosquito counts prevailed.
- Mosquito-transmitted disease was a hot topic through September with Eastern Equine Encephalitis and California group encephalitis being reported in residents throughout Michigan. Neither virus was evident in Bay County in mosquitoes or humans. Much discussion ensued with local mosquito control districts, public health officials, and vendors to discuss control and surveillance strategies.
- Multiple 1-2" rain events in September created standing water in ditches. Ditch trucks
  were employed for ditch treatment to control larvae. This lead to a slight increase in
  mosquito counts (Ae. vexans) at the end of September. However, cooler nightly
  temperatures lead to minor nuisance for residents.
- Bay County Mosquito Control participated in the Consumers Energy Family Safety Day on August 22. The Mosquito Control booth had great interest from attendees and included insect repellent giveaways and live larval samples for education.
- The second tire drive of the season was held Saturday, August 3 at Fraser Township Hall with 479 tires collected. The costs of holding the tire collection are covered through a 2019 DEQ Scrap Tire Clean-Up Grant.
- An application for a 2020 DEQ Scrap Tire Clean-Up Grant up to \$8,000 was submitted in late August.
- A two year contract rollover was awarded to Earl's Spray Service of Breckenridge for spring woodlot aerial treatment at \$4.25/acre. Earl's Spray Service treats over 52,000 acres of flooded woodlots via 3 fixed-wing aircraft during the aerial treatment program.
- Biology staff conducted a field evaluation of the BG-Counter mosquito trap. This unit
  was attached to a CDC trap and provided electronic counting of insects entering the
  trap using lasers and algorithms. This data was provided wirelessly to a website where
  staff could view updated information every 15 minutes of how many insects were
  collected in the trap and how many were suspected to be mosquitoes.

- Bay County Mosquito Control staff attended the 24<sup>th</sup> Annual MiCamp Fall Mapping Conference September 18-20 at Boyne Mountain. Presentations provided attendees the opportunity to learn about new advances in GIS mapping and how other government agencies use the program to increase efficiency and accuracy.
- The mosquito control treatment season ended October 1 due to unfavorable weather conditions and low nightly temperatures minimizing mosquito activity.

## HEALTH

#### Administration

- 1. The Bay Community Health Clinic enters its fourth third year of operation. The clinic is a cooperative clinic project with Saginaw Valley State University and focuses on persons with multiple chronic conditions, who are uninsured/underinsured, especially veterans and persons with behavioral health issues. The University has again secured a grant from the Health Resources Services Administration (HRSA) to fund an extra day of operation which began in February 2019. The extra clinical day is done in cooperation with Recovery Pathways LLC and provides substance abuse treatment to persons over the age of 60.
- 2. Representatives from MDHHS presented the Health Department with its accreditation award at a Board of Commissioners meeting on September 10. The Health Department successfully met 133 out of 137 indicators (97%) pertaining to program operations in over a dozen areas.
- 3. The Environmental Health Division continues to implement a \$160,000 grant to digitize and map septic and well systems within the county that was awarded by the Michigan Department of Environmental Quality (MDEQ). The grant will allow the Health Department to determine areas of risk for water quality due to failing or at risk septic systems and assist home owners in discovering problematic areas. This digital mapping project for septic systems is the first of its kind in the state of Michigan and the United States. At the time of this report, nearly half of all parcel information has been entered into the database and mapped.
- 4. The Health Department continues to work within the community to implement projects from a grant dealing with the Opioid Crisis in the community totaling \$75,000. The Health Officer met with representatives from Amalgam LLC regarding a surveillance database of overdoses and also worked with the Michigan Health Improvement Alliance to stage a regional Wide Opioid Forum at the Lincoln Center on August 13th.
- 5. The Health Department is working with a consortium of community partners on bacterial source tracking and qPCR projects in surface and beach waters in the Saginaw Bay. One key partner, SVSU's Department of Chemistry has developed and published a methodology that is unique to the Saginaw Bay. SVSU is also diligently working on preliminary results of source tracking samples taken in 2018. In addition, BCHD is working with the University and the State of Michigan on a series of videos that explains the necessity of testing for bacteria in surface waters, the nuts and bolts of testing, old methods vs. new methods and how to prevent illnesses. SVSU hosted forums on beach closures August 20<sup>th</sup> and on the State of the Great Lakes Bay in September where the Health Officer presented information regarding the Fetch Mapping system for septic systems (see above #3) on September 26.
- 6. The Health Department was granted authorization by the Bay County Board of Commissioners to hire a new Medical Director and Medical Examiner. Dr. Thomas Bender was selected as the Medical Director and Dr. William Morrone was selected as the new Medical Examiner.

7. The Health Department worked diligently through the summer with Mary Kushion to develop its third strategic plan since 2011. The new strategic plan, which is set to be implemented in January of 2020 incorporates feedback from all of its employees, as well as community members and organizations that work closely with the Health Department, policy makers and county commissioners. Main areas of interest within the plan include, but are not limited to, continued fiscal responsibility and sustainable growth within the department; increasing opportunities for access to care within the community and the department; improvements in work environments; workforce development planning and improved community outreach efforts.

#### Children's Special Health Care Services (CSHCS)

- CSHCS provides supplemental insurance benefits and services of a registered nurse to children who have a qualifying medical diagnosis. A child is invited to enroll whether they have private insurance or a Medicaid Health Plan. Staff assists families to navigate the medical, health insurance and educational world of the child with medical special needs. These services promote optimal functioning for the child and family.
- The program employs two FTE nurses and one 0.5 FTE clerical. It also is a recipient of a MDHHS mini-grant of \$10,000 to hire a CSHCS Parent Liaison to provide outreach activities to CSHCS families.
- CSHCS staff participates in a monthly MDHHS CSHCS conference call.

#### Communicable Disease (CD) Division

- CD has 2 PHN in the department. In 2019, latent tuberculosis infection (LTBI) was added as a reportable disease as well as Rabies Post Exposure Prophylactic (PEP) human. The investigation on both of these reportable diseases is time consuming. Also in 2019, one CD nurse has been pulled for coverage to another department on a consistent basis. The CD nurses are also responsible Direct Observation Therapy (DOT) for LTBI and TB and more practitioners are using the 12 week, once weekly dosing, DOT for LTBI which has placed an increased demand on the CD nurses.
- As a result in addition to the confirmed and probable cases sites below, there are were 27 Hepatitis C-acute; 3 Hepatitis C-chronic; 38 Chlamydia and 6 Gonorrhea cases reported this quarter that remain unknown status since CD staff has been unable to complete the disease investigation.
- The CD nurses investigated 278 reportable disease cases this quarter, of which 160 were confirmed or probable. For reporting purposes, MDHHS considers probable cases as confirmed disease.

Inv Grp A; 1Septococcus pneumoniae, drug resistant; 1 Rabies-animal; 52 Rabies (potential exposure & PEP -prophylaxis); 1Nontuberculous Mycobacterium; 3 Latent Tuberculosis infection; 1 Tuberculosis-suspect (being treated as confirmed case until cultures in); 1 Shingles; 1 VZ Infection, unspecified; 1 West Nile Virus; 3 Hepatitis B-chronic; 1 Hepatitis C-acute; 3 Hepatitis C-chronic; 1 Hepatitis C Perinatal; 57 Chlamydia and 14 Gonorrhea.

#### Personal Health Family Planning Clinic

- The Personal Health Family Planning (PHFP) Clinic is a Title X Clinic that provides sexual and reproductive health and contraceptive services to woman, men and teens. Client receives both contraceptives and STD services. Staff currently includes 1 FTE nurse, clerk and a FP Coordinator, and 2 contracted Nurse Practitioners who each work one day a week in the Clinic. Although the nurse and clerk are temporary due to unexpected leave of the permanent employees, they have caught on well to the job responsibilities.
- All staff participates in a monthly staff meeting and professional staff attended the MDHHS Annual Family Planning Conference in September in Traverse City, MI.

#### **HIV/AIDS Testing Outreach**

- Rapid HIV testing is now available by appointment every Wednesday at the BCHD free of charge. Clients seen in the Personal Health Family Planning or Bay Community Health Clinic, can receive same day Rapid HIV testing if the HIV nurse is available, otherwise these clients schedule an appointment with the HIV nurse. Serum HIV testing is always available in the clinics.
- 28 Clients were tested for HIV this quarter: 16 males (2 were court ordered) and 12 females. All HIV results were negative.

#### **Hearing and Vision Program**

• The Hearing and Vison technicians provide hearing and vision screenings in preschools and schools. Children who do not pass the screening are referred for medical care. Technicians follow up on referrals to assure children receive medical care.

- Healthy Homes and Lead Poisoning Surveillance System (HHLPSS) is the MDHHS system
  to report on blood lead levels for all children in Michigan. It assists the local health
  department (LHD) by identifying children in their jurisdiction who have an elevated
  blood lead level (EBLL) > 5mcg/dl and need further medical care.
- Utilizing funds from the Local Maternal Child Health Block grant a PHN is able to follow up on all reports of capillary EBLL by providing education and guidance over the phone. Children who have a confirmed venous EBLL > 5 mcg/dL are offered PHN case management in the form of a home visit. These visits are provided regardless of insurance coverage.

Project FRESH provides healthy and nutritious produce to WIC clients, while fostering economic development by promoting our state's diverse agricultural products. The program provides eligible WIC clients with locally grown, fresh, unprepared fruits and vegetables from authorized farmers, farmers' markets and roadside stands throughout Michigan. ## **JUVENILE DETENTION & CHILD CARE SERVICES**

- The Child Care grant has not experienced any budget cuts for the fiscal year and has maintained continued programming. October 1, 2019 starts a new year for the Child Care Fund.
- The Juvenile Home experienced 2,162 days of out of county residents for FY 2019 which totals to \$330,786 of revenue. The most recent quarter there were 307 days of

out of county residents billed for \$46,971. This is an increase from FY 2018.

- The facility experienced 4 restraints in the last quarter and 6 seclusions. In incidents mentioned above there were no injuries to residents or staff.
- Residents participated in ongoing education program provided by the Bay Arenac Intermediate School District.
- Representatives from the MSU Extension provide life skills programming for residents.
   Programming included the Harvest for All in which residents helped raise chickens. At the end of the program chickens were processed and given to needy families.
- A representative from the Neighborhood Resource Center provides weekly Life Skills classes
- A spiritual program for resident has been implemented. It is non-denominational and voluntary for residents to participate. The residents have enjoyed the program with most attending. The program is provided by Forgotten Youth Ministries.
- Bay Arenac Behavioral Health (BABH) implemented a program to increase pro-social skills with the youth detained in the facility. BABH assess resident needs and meet with the residents four days a week.
- The contracted medical provider met with residents on a variety of issues and maintained medication management for residents.
- The Health Department provided immunization clinics for residents.
- The BCJH staff completed a total of 329 hours of training this year. All staff are to complete a minimum of 25 hours.
- The Director attended the Michigan Juvenile Detention Association Conference at Higgins Lake.
- The Director completed a grant application for the Justice Assistance Grant of \$16,320 utilized by law enforcement.
- School Nutrition Program FY 2019 ended on 6/30/19. The total reimbursement for the 2018/2019 school year \$22,055.55. The total reimbursement for the 1<sup>st</sup> quarter July/September was \$6629.56.

 Average daily population was 11 for this quarter. Average daily population January thru September 2019 is 11. This is due in part to low census at the beginning of the year we have since increased our out of county population above the allotted 6 beds.

#### **Community Corrections**

 Vendor contracts for FY 2020 were submitted to Assigned Counsel in August. 95% of documentation has been entered into Northpointe data base for FY2019. Year -end report is due 10/31/19. Last CCAB meeting for 2019 will be held on 10/23/19 to approve the report.

- At a rate of \$67.28 daily for housing offenders, these 5 programs combined have saved the county over \$2 million from beginning of fiscal year to August 2019 by supervising offenders in the community with treatment and offering education and SUD treatment in the jail. These programs assist with jail overcrowding and bed space utilization as well.
- One of the objectives for Community Corrections is to reduce the overall Prison Commitment Rate to 19% or below, this is the new goal for 2019. Bay Co did reduce its rate by 2% for 2018. The rate for 2018 was 21% and 2017 was 23%. Group 2 Straddle cell rate went up by 1.9 pts to 36.4% from 34.5% in 2017. It may be due to the Heroin epidemic that has plagued Bay Co. The information above is related to people that were sent to prison. Bay Co will continue to try and keep the prison commitments low by utilizing the treatment programs funded through PA511 and other sources.
- Throughout this quarter, the Manager has attended Drug Treatment Court Team meetings and TRICAP Board Meetings. Also attended State Board meetings and Pretrial Training. The Manager also hosts the CCAB meetings with Community Corrections board members.

#### **MSU EXTENSION**

#### Children and Youth Program (4-H), Jodi Schulz

• Jodi is part of a team of staff that work state-wide to support out 4-H International Exchange program. Part of her support is working with 4-H staff to train them in doing on-site home visits and interviews for potential host families. This is part of State's 4-H international program protocol, but also part of the Michigan 4-H program policy. Jodi trained and assisted staff in Tuscola County to do these home visits and interviews. The international exchange student the family was slated to host was a

teen from Japan.

- Jodi continues to do trainings state-wide for staff, adult volunteers, and youth volunteers. She conducted two SAFE trainings in Ingham County and Oakland County, two Interviewing Skills Training in Saginaw County and Muskegon County, three 4-H Leader Trainings with volunteers in Shiawassee County, and one training with Fish Camp Counselors (teens) in Bay County.
- As PI on the AmeriCorps grant (\$455,760 from funder and \$164,205 in match funds), we are now entering year two of the three-year grant. Significant time has been spent closing out year one and preparing year two. Preparing included recruiting host sites (counties), reviewing their applications, identifying full and half time members, discussion with Co-PI and project manager about changes that need to occur in year two, communication strategies, and planning AmeriCorps member orientation for October.
- MSU Extension is in the process of implementing significant changes to the volunteer structure and screening processes. We are currently working with a company in Utah to build a centralized website and computer system that will house the components of our screening: application, references, background check, interview notes, etc. Jodi's role with this project is focused on staff training. As the system is built and available to staff, she will conduct trainings around the state.
- Jodi is providing leadership to a state-wide file review project related to volunteer screening. She is providing support and training to staff. This project is ongoing through 2020.

## Child and Family Development, Kylie Rymanowicz

• In partnership with the Eastern Great Start Regional Resource Center, I was contracted to do a two-and-a-half-hour training program for early childhood professionals. I taught "The Importance of Outdoor Play" about how to structure and support outdoor play experiences that support early learning and school readiness. I trained 10 adults. 137 children ages 0-8, and 36 children 9-12 were impacted because of this training. One participant shared that they planned on talking more about play with children and expanding outdoor activities.

#### 4-H Program Coordination, Holly Julian

• Summer time was a busy time for Bay County 4-H. The Bay County 4-H club had a great turn-out for the Bay County Fair and Youth Exposition. They had 107 exhibitors, which was very evident in the Livestock, Horse Barns, and the Canteen building where the Still Projects (crafts) are housed. The Livestock Barn was completely full this year with 4-H animal projects. Chicken eggs hatched during fair week, as well. This is a great way for our 4-H youth to engage the community while they are looking through the barns and seeing all the 4-H animal projects. In the Horse Barn we almost double the quantity of horse projects this year.











• Programming has commenced again in the schools. Bay County 4-H helped facilitate Bangor Central Elementary in their Science Family Engagement night. They had a great success and look forward to many more Family Engagement nights this 2019-2020 school year. They also started programming at Hampton Elementary, in the 2<sup>nd</sup> grade classrooms, with the school enrichment program. This program reinforces the teacher curriculum introducing the following activities include; landforms, fractions, measurement, re-grouping, money, plant parts and soybean necklaces, and many more activities.

#### SNAP-Ed Nutrition Education, Karen Parker

• MSU Extension Health and Nutrition partnered with Bay County Department on Aging and the Bay City Housing Commission, in July and August, to distribute Senior Project FRESH/Market FRESH coupons to seniors in Bay County. Each were given a \$20 book of coupons to purchase locally grown fruits and vegetables. The seniors were income eligible and living in Bay County. This program helps to stretch food dollars, as well as increase fruit and vegetable consumption. MSU Extension explained how and where to use the coupons and presented nutrition education to the participants. Senior Market FRESH also reinforces the importance of enjoying local food which in turn, helps

Michigan farmers by giving back to our local community.

• The Boys and Girls Clubs of the Great Lakes Bay Region held BeFit Festivals at their 3 locations in Bay County. The festivals were centered around physical activity. Kids of the clubs and parents attended. The 3 clubs averaged 250-300 in attendance for each. A great time was had by all!

#### Michigan Sea Grant Extension Educator, Meaghan Gass

- As an Extension Educator with Michigan Sea Grant, Meaghan supports programming that applies science-based knowledge and addresses Great Lakes issues around the Saginaw Bay region. In July, Michigan State University Extension, Bay County 4-H, Michigan Sea Grant, and many local partners hosted the Saginaw Bay 4-H Fish Camp to encourage more outdoor recreation and enjoyment of the fishery in Saginaw Bay. At the camp, 35 youth learned how to fish and connected to Great Lakes issues including invasive species, marine debris, food webs, and more. Teen counselors also had the opportunity to develop as leaders throughout the camp and help share their experiences fishing with youth. Through donations from the Saginaw Bay Walleye Club and the Future Anglers Association, they received a rod, reel, and tacklebox in order to continue to fish and develop as an angler.
- Thank you to the partners who supported these workshops: Bay City State Park, Bay County Health Department, Future Anglers Foundation, Michigan Department of Natural Resources, Project F.I.S.H., Saginaw Bay Walleye Club, and many volunteers.
- In July, Meaghan hosted a Microbial Source Tracking in the Saginaw Bay Watershed Webinar in partnership with Bay County Health Department, Michigan Department of Environment, Great Lakes & Energy, and the Environmental Protection Agency. This webinar highlighted the microbial source tracking project and how rapid bacterial testing for local fresh waterways, especially beaches, is being implemented in the Saginaw Bay Watershed. The webinar had over 100 attendees, and more than 200 people registered for the webinar.
- In August and September, Meaghan partnered with Michigan Department of Natural Resources, U.S. Fish and Wildlife Service, Saginaw Bay Watershed Initiative Network, Bay County Environmental Affairs and Community Development, and many local partners to host 8 lake sturgeon release events into the Saginaw Bay watershed. The releases reintroduced 1000 hatchery-raised sturgeon into four tributaries of the Saginaw River (Cass, Flint, Shiawassee, and Tittabawassee rivers). Learn more about this effort by visiting www.saginawbaysturgeon.org.
- In August, Meaghan hosted a Sturgeon in the Classroom webinar (https://youtu.be/-IKMwB82f90) in partnership with Michigan DNR, MSU Department of Fisheries and Wildlife, and Little Bay Band of Odawa Indians to share best practices for sturgeon aquarium husbandry. This fall, three classrooms, including Bay City Western Middle School, will continue raise lake sturgeon in the classroom and release the fish into the Saginaw Bay Watershed in the spring.
- Lake sturgeon are a unique Great Lakes species. They can grow up to 7 feet long and can weigh up to 300 pounds. The slow-maturing fish do not begin reproducing until

they are 15-20 years old. Once abundant in many Michigan lakes and rivers, lake sturgeon were nearly eradicated due to overfishing and habitat loss, particularly the destruction of rocky reefs in rivers that sturgeon and other native fish species use for spawning. In recent years, many partnerships and projects are working to restore sturgeon to a self-sustaining level in Michigan. This work includes restoring sturgeon habitat, reintroducing sturgeon into their native ranges, and raising awareness and appreciation for this unique species.

- Throughout the summer, Meaghan continued to provide support for the Saginaw Bay Reef Restoration Project through education and outreach - including having youth and community members decorate rocks to be used in the newly installed reef.
- Through this effort, federal, state and local partners will construct and restore rock reef habitat at the historic Coreyon Reef. The restored reef will create important spawning habitat for many native fish species, and it will also help to facilitate a more resilient and diverse fish population. The construction of the Coreyon Reef is anticipated to be completed by the fall of 2019, and funding for the construction of the reefs was provided through the U.S. Environmental Protection Agency, Great Lakes Restoration Initiative and the Saginaw Bay Watershed Initiative Network. It is supported by many partners including Bay County Community Development and Environmental Affairs. For more information, please visit http://www.miseagrant.umich.edu/saginawbayreefstudy/.
