

**NOTICE OF ELECTION  
TO THE QUALIFIED ELECTORS  
OF BAY COUNTY, MICHIGAN  
TUESDAY, NOVEMBER 3, 2015**

**NOTICE IS HEREBY GIVEN** that an Election will be held in the County of Bay, State of Michigan on Tuesday, November 3, 2015 at which time the following offices and proposals are to be voted for. The polls will be open from 7:00 a.m to 8:00 p.m. Eastern Standard Time.

**Offices to be Voted:**

Bay City Mayor  
Bay City Commissioners Wards 2, 4, 6, 8  
City of Essexville Council Members

**Proposals:** The following is a summary of two (2) ballot proposal which shall be considered by the electorate at the November 3, 2015 ballot in the City of Essexville and Township of Frankenlust/Freeland Community Schools.

1) **City of Essexville Bond Proposal-** Shall the City of Essexville borrow an amount not to exceed \$6,950,000 and issue general obligation unlimited tax bonds for the cost of making water supply system improvements of a water transmission line that will connect the City system to the Bay County Regional Water Treatment Facility? The max number of years is 40 years with the estimated levy in the first year of 2.6931 mills (equal to \$2,6931 per \$1,000 of taxable value of real/personal property in the City), millage to retire the bonds 2.7647 mills.

2) **Freeland School District Bond Proposition-** Shall the Freeland Community School District borrow the sum of not to exceed \$22,395,000 and issue general obligation unlimited tax bonds for the purpose of erecting, furnishing and equipping additions and to remodel, furnish and equip school buildings, technology, bus garage, purchase school buses, athletic fields, playgrounds and sites? (In 2016 is 3.29 mills to the max of 4.0 mills on \$1,000 of taxable value)
